Return this completed form, along with a copy of your sales receipt with the purchase price circled and your installation/delivery receipt. **IMPORTANT:** You must cut out and include the original label from the Plasma HDTV carton, which includes the UPC code, model number and serial number, or your claim cannot be processed. If a claim is denied for any reason, resubmission of all requested materials must be postmarked within 30 days of denial, only one resubmission attempt per claim will be allowed.
3. Only handwritten responses will be accepted. No stickers or preprinted address labels. Product must be new and un-used.
